<p>What is the overall deductible?</p>	<p>For preferred providers \$250 member/\$750 family; for out-of-network providers \$750 member/\$2,250 family</p>	<p>Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan, each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible.</p>
<p>Are there services covered before you meet your deductible?</p>	<p>Yes. Preferred providers services for preventive care, preferred provider physician office visits, preferred provider urgent care, QuestSelect™, emergency room visits, preferred provider or non-preferred provider services for non-specialty prescription drugs, and child immunizations are covered before you meet your deductible.</p>	<p>This plan covers some items and services even if you haven't yet met the deductible amount. But a copayment or coinsurance may apply. For example, this plan covers certain preventive services without cost-sharing and before you meet your deductible. <p>Will you pay less if you use a network provider?</p>	<p>Yes. You will pay the most if you use a out-of-network provider and you might receive a bill from a provider for the difference between the provider's charge and what your plan pays (balance billing). Does this plan provide Minimum Essential Coverage? Yes.
